Section 32 of the Employment Act sets out a number of such breaches, and also makes provision that such acts are not limited to those set out. These include: Theft, fraudulent offences, dishonesty, gross insubordination or insolence; gross indecency, breach of confidentiality, gross negligence, incompetence, gross misconduct.

Labor & Industries (L&I), Washington State

Regulations of executive branch agencies are issued by authority of statutes. Like legislation and the Constitution, regulations are a source of primary law in Washington State. The WAC codifies the regulations and arranges them by subject or agency. The online version of the WAC is updated twice a month.

Washington Administrative Code (WAC)

The National Labor Relations Act forbids employers from interfering with, restraining, or coercing employees in the exercise of rights relating to organizing, forming, joining or assisting a labor organization for collective bargaining purposes, or from working together to improve terms and conditions of employment, or refraining from any such activity.
