Diagnosis codes. Positive COVID. Assign code U07.1, COVID-19, for a confirmed diagnosis of the 2019 novel coronavirus disease (COVID-19) as documented by the provider, a positive COVID-19 test result or a presumptive positive COVID-19 test result. Confirmation does not require documentation of the type of test performed; the provider's documentation that the individual has COVID-19 is sufficient.

How to code for COVID-19 diagnosis, testing, telehealth ...

If you order diagnostic services for Medicare patients, you must also maintain documentation of the order or intent to order and medical necessity of the services in the patient's medical record. Keep this information available and submit it, along with the test results, upon request for a Medicare claim review.

Complying with Documentation Requirements for Laboratory ...

A coder cannot use documentation found in lab, radiology, pathology or other test results. A physician or clinical practitioner (i.e., APRN, PA) must review, interpret and document the clinical significance of the results in the Progress Notes. By law, the coder must rely only on what the treating clinicians enter into the patient record.

Commonly Asked Physician Clinical Documentation Questions

If the physician has confirmed a diagnosis based on the results of the diagnostic test, the physician interpreting the test should code that diagnosis. The signs and/or symptoms that prompted ordering the test may be reported as additional diagnoses if they are not fully explained or related

Answer: If the provider still documents and confirms COVID-19 even though the test results are negative, or if the provider documented disagreement with the test results, assign code U07.1, COVID-19. As stated in the Official Guidelines for Coding and Reporting for COVID-19, "Code only a confirmed diagnosis of the 2019 novel coronavirus disease (COVID-19) as documented by the provider... the provider's documentation that the individual has COVID-19 is sufficient."

Documentation guideline: The review of lab, radiology and/or diagnostic tests should be documented. An entry in a progress note, such as "WBC elevated" or "chest X-ray unremarkable," is acceptable. Alternatively, the review may be documented by initialing and dating the report containing the test results.
