If your application goes through and your discharge is upgraded, you'll be eligible for the VA benefits you earned during your period of service. All branches of the military consider you to have a strong case for a discharge upgrade if you can show your discharge was connected to any of these categories:

Discharge Review Boards cannot consider any discharge resulting from a sentence given by a general court-martial. If the discharge you want reviewed was issued more than 15 years ago, you must submit an application to the appropriate Board for Correction of Military Record using the DD Form 149, Application for Correction of Military
