After KCC receives and processes the DS-260 application form for you and your accompanying family members, you will receive instructions for how to submit required supporting documents. Your interview will not be scheduled until you submit scanned copies of all required supporting documents, following the guidelines below.

Submit Supporting Documents - Travel
After you complete your DS-260 (s), you and each family member immigrating with you MUST collect the civil documents required to support your visa application. Your civil documents MUST be issued by the official issuing authority in your country. Please refer to the Document Finder to learn about the civil document requirements for each country.

Civil Documents - Travel
Once the DS-260 form has been completed, supporting documentation must be gathered for submission; some of these documents include birth certificates, vaccination records, marriage or divorce decrees, and diplomas.

DS-260 Immigrant Visa Electronic Application - Frequently ...
You will not be able to upload any civil documents for a visa applicant until he/she has submitted the immigrant visa application. It will say N/A (not applicable) in the Civil Documents column until the Form DS-260 immigrant visa application is completed on CEAC. If you started uploading documents but did not finish, it will say Incomplete. 1 2

HOW TO UPLOAD DOCUMENTS TO CEAC
Civil documents must bear an original signature, stamp, and seal of the issuing office or registrar. Copies certified by attorneys, Justice of the Peace, Notary Public, etc., are not acceptable. For any document not in English or in the official language of the country from which you are applying, a notarized translation is required in addition ...

Civil Documents for USA Immigrant Visa - Consular Processing
IMPORTANT: Do not send any documents to NVC by mail.However, you must bring every civil document you uploaded and submitted with your application to your visa interview. To submit documents, log into CEAC and go to the "Start Now" buttons located under Affidavit of Support Documents and Civil Documents.When you have uploaded all the required documents for each section, press "Submit ...
