Chapter XXII of the Act contains provisions relating to prosecutions. Amongst other provisions, Section 276C of the Act contains provisions relating to prosecution against "wilful attempt to evade any tax, penalty or interest chargeable or impossible or under-reporting of income or, to evade payment of such tax, penalty or interest".

In the income tax return filed on December 28, 2012, the assessee had declared 'Nil' income after claiming application of income as per Section 11 and 12 of the IT Act. The assessee had shown expenditure incurred on the purchase of fixed assets as application of income, and it had further claimed depreciation on such assets.
